

ABORTION CALL

Wade on June 24, 2022; resolution of all unresolved cases of subsequent 96 violent acts perpetrated against pro-life pregnancy centers, churches, their employees, volunteers, and first responders; and full pardons of jailed pro-lifers and termination of employment for FBI officials involved in their persecution.

CONTINUED LEGISLATIVE ACTION TO RESTRICT ACCESS TO Mifeprex (mifepristone), the deadly abortion pill, and the FDA'S decision in 2000, to approve this drug, disregarding normal drug approval protocols, placing political expediency above health and safety of women, resulting in the death of 5.6 million preborn children since approval in the U.S., with over 63% of abortions in America now committed by this drug; enforcing the law that the FDA is required to publish all provider reporting of serious adverse events after use of this abortifacient, Mifeprex (mifepristone); outlawing all telehealth visits and mail orders for prescribing and dispensing this drug;

and turn back all further loosening of restrictions by the FDA since January 2023 to allow major pharmacies to dispense the abortion pill.
